## THE 2024 JOHN C. SHEPHERD

### Graduation Speaker

**John C. Shepherd**, a 1951 graduate of Saint Louis University School of Law, was an internationally recognized trial attorney with an extensive background in the law. He was a senior partner at the law firm of Armstrong, Teasdale, Schlafly & Davis. Prior to his position with the firm, he was the senior partner and chief executive officer of Shepherd, Sandberg & Phoenix.

Shepherd lectured on trial techniques throughout the United States, Canada, England, Ireland, Scotland, Australia and New Zealand. As one who fulfilled a variety of leadership positions within the legal profession, his work with the American Bar Association's Summer Internship Program was particularly rewarding. Shepherd and his colleagues played a role in helping the program become a model for many cities.

He was a past president of the American Bar Association, chairman of the House of Delegates of the American Bar Association,

the state delegate for Missouri to the American Bar Association and president of the Bar Association of Metropolitan St. Louis. Shepherd also served as chairman of the Board of Overseers for the Hoover Institute, and was a member of the Board of Trustees for the United States Supreme Court Historical Society. He was also on the Board of Directors for Barnes Jewish Hospital, the Municipal Theatre Association and Illinois College.

Shepherd was the recipient of numerous awards and honors, which include among them the Honorary Master of the Bench, the Middle Temple and the Honorary Life Member of the Law Society of England and Wales. He was also given the Lon O. Hocker Memorial Trial Award from the Missouri Bar Foundation, the Award of Honor from the St. Louis Lawyers Association, the Award of Merit from the Bar Association of Metropolitan St. Louis and the Alumni Merit Award from Saint Louis University.

## THE 2024 JOHN C. SHEPHERD GRADUATION SPEAKER

### Hon. John MacMenamin

SENIOR ORDINARY JUDGE OF THE SUPREME COURT OF IRELAND, RETIRED

Judge John MacMenamin was Senior Ordinary Judge of the Supreme Court of Ireland when he reached the statutory retirement age of 70 in November 2022. During his career on that court Judge MacMenamin delivered significant judgments, some of them described by commentators as “landmark” in the areas of constitutional and administrative law. These included decisions on enforcement of judgments, statutory interpretation, the employment rights of persons with disabilities, the duties of local authorities in housing members of minorities, negotiation rights of trade unions, prison accommodation, and (dissenting) on the quasi-judicial role of administrative authorities.

For three years, Judge MacMenamin was Ireland’s representative on the Consultative Council of European Judges; an advisory body to assist and support judicial independence in Western and Eastern Europe. He has participated and spoken at conferences from North Macedonia to Latvia and represented the European Union at judicial conferences in Ukraine. In 2020, Judge MacMenamin participated in the “March of 1000 Robes”; a procession of one thousand judges from throughout the European Union to support judicial independence in Poland. He was Judge-in-Residence at Dublin City University and Adjunct Professor of Law at National University of Ireland Maynooth. In 2018, Judge MacMenamin taught a course in Comparative Constitutional Law at

NALSAR Hyderabad in India. Judge MacMenamin is no stranger to Saint Louis University School of Law and its alumni. In 2017 and 2019, he spoke at Saint Louis University School of Law on the European Union, and on challenges to the Rule of Law in Europe.

Prior to serving on the Supreme Court of Ireland for ten years, Judge MacMenamin served on the Irish High Court for eight years. Previously, as a barrister and senior counsel, he specialized in administrative and defamation law. In one well-known defamation case he participated in an evidence hearing at the headquarters of the Communist Party International in Moscow. In Ireland, Judge MacMenamin appeared as lead counsel for prominent parties in several Judicial Tribunals and acted for the state in a Judicial Commission on the treatment of children in state-run institutions.

Judge MacMenamin was Chairman of the General Council of the Bar of Ireland from 1997-1999. He is currently Chair of the Irish Financial Services Appeals Tribunal, engaged in an extra-legal restorative justice process for a religious order, and a member of the Governing Authority of University College Dublin, his alma mater.

Judge MacMenamin is married to Lia O’Hegarty, who was previously the first Legal Adviser to the Irish Parliament. They have a fourteen-year-old daughter. Judge MacMenamin’s interests include history, art, literature, and rock music of a certain era.
